A. Budget/Treasurer

George Vandersluis has agreed to accept the position of Treasurer and will review the Strawman Budget prepared and submitted by Don Holmes. The Good Guys Fund was designated as a fund for Highpointer Club projects. The Paul Zumwalt fund was renamed the Paul Zumwalt Museum and Educational Fund and is to be used for educational purposes. The issue of changing club dues was tabled until the budget has been reviewed by the Treasurer to determine if an increase in dues is either required or warranted.

B. Highpointers Club Paper Weight Medallion

The issue of having a Highpointers Club paper weight medallion was tabled until a cost effective process is determined.

C. Bylaws

Copies were distributed and input/comments are to be returned to Don Holmes as soon as possible. This item was tabled until the next meeting.

D. Non-profit Organization

Bob Failing has agreed to research this issue. His committee will report back to the Board of Directors.

E. Newsletter Status and Survey

John Mitchler announced an 18% response to the national survey. The main purpose of the survey was to obtain feedback on format and content. A membership directory will continue to be published in the first newsletter annually. There will be no paid advertising in the newsletter at this time.

The motion passed unanimously. The Board is currently looking for a committee chairperson to oversee this project. Volunteers are Jack Longacre and Paul Zumwalt.

J. Life Memberships

The Board decided not to offer Life Memberships in the Club at this time. Honorary

and Distinguished memberships will be reviewed on an individual basis.

K. Private Property Liaison

The Board approved a motion to have Jack Longacre appoint a representative from the Club to deal directly with private property highpoint landowners. This person shall also nominate highpoint landowners for awards, etc.

L. District of Columbia Highpoint

Robert Hyman agreed to look into officially locating and naming the District of Columbia highpoint.

M. Board Members

The Board decided to designate all "Staff" and "Board" members as members of the Board of Directors.
